### **Primary Care Data Gathering Programme:**

## Roll out of 3 and 6 facet surveys to over 1,000 GP practices

NHS England's Facet Survey Programme was part of the second phase of the Primary Care Data Gathering Programme that is intended to bring the information held on General Practice (GP) premises in England up to a consistent baseline standard nationally.

gbp consult was commissioned by Community Health Partnerships (CHP) via the local LIFT Companies to programme manage the rollout of **3** and **6** facet surveys for GP premises across Integrated Care Systems (ICSs) in England. Many of these ICSs were in varying stages of maturity having transitioned from Clinical Commissioning Groups (CCGs) in 2022, which required bespoke levels of management and support.
